165-175 Kindly amend this section to read as benefits.

Industry already shares information with regulatory authorities. Full clarity is required of extent of data sharing in the network, and of security and confidentiality measures applied. Some member states already have information shared between industry and regulators for drug shortage prevention. For efficiency EMRN should build on this experience. Harmonisation and interoperability are critical for this project. ISPE suggests an implementation road map is drafted.

266-289 Management of data requires more clarification. ISPE recommends that two roles are considered across the whole network – Governance (e.g. policies, processes, hardware, validation policy) and Content (e.g. correctness of data, nomenclature) After line 332, consider adding in "Data Principles" add an additional section for "Representative Data". Text should explain the strategy that data reflect real-world diversity and be regularly assessed for biases within the intended use.

As important to the strategy, consider making ISO 2700x series standards mandatory across the network and, potentially with other stakeholders who connect to EMRN.

High levels of data control and prevention from cyber-attacks are an essential strategic objective.

87 Key challenges:add "Connection to existing company management, business strategies and data structures" 103 Scope:clarify if all companies should comply e.g. for all (review and inspection) CMC data. Please provide a reason as well. Some companies may have to develop policies and infrastructure. 113-118: mention scope is wider than current expectations for regulatory data. Please include text explaining the scope of data relating to inspection and drug shortage prevention.
